## Dear Friends,

One of the many ways the Community Foundation contributes to a vibrant Capital Region is by ensuring a strong and innovative nonprofit sector. We engage in this vital work using the principles of Trust Based Philanthropy (TBP), which provides a framework that builds a positive relationship between funder and grantee. Over the past two years, the Foundation has implemented meaningful trust-based practices such as simplifying our applications and streamlining the grant process; increasing transparency; soliciting and acting on feedback; and providing support beyond the check. We are energized and eager to continue building valuable and sustained relationships with our nonprofit partners throughout the Capital Region.

Another way we help build vibrant communities is by leading placemaking initiatives along the Michigan Avenue corridor – the backbone of our three-county region – including the downtown Lansing riverfront. Early on, we recruited a technical team of urban planners from MSU, the City of Lansing, and many other field experts. Together, we developed a master plan for the riverfront - a "string of pearls" that, once completed, will be a series of vibrant public spaces for all, linked along the river and the river trail.

Two of those pearls are the ever-popular **Rotary Park** and the new destination **Play Michigan!** all-inclusive playground. Now the new Fish Ladder Music Park near Old Town is underway, to be completed in 2025 (see page 23). Three or four other riverfront pearls are on the drawing board depending on interest by individual donors and corporate investors who recognize that a vibrant, fun community attracts and retains employees. Delta Dental, AF Group, Auto-Owners, CASE Credit Union, and many other businesses believe in the return on their investments to date.

As delightful as these riverfront gems are, infrastructure alone won't necessarily draw people. We've learned from other riverfront cities that the key to vibrancy is activation, such as events, entertainment, and food offerings that entice both residents and visitors.

This lesson has taken the Community Foundation in a new, complementary direction.

In addition to sponsoring six major festivals this year (see page 24), we are creating a new position on our team, a Director of Riverfront Operations. This talented professional will work in concert with the City's Parks and Recreation Department, Downtown Lansing Inc, LEPFA, Choose Lansing, and other partners.

We can't wait to watch our Riverfront Director lead the way to a destination we will all enjoy and be proud of.

## **Our Equity Journey**

The journey toward greater equity in our work proudly continued in 2023 and continues today. As a community foundation, we remain focused on the many opportunities we have to support those with different cultures, backgrounds, and abilities. With a critical eye focused on building greater racial equity, particularly through our funding, the Community Foundation continues to listen, learn, and better understand our role in building more inclusive communities around the Capital Region.

Much of our work in this space continues with the leadership of our Racial Equity Committee. This group has helped build valuable connections with small, grassroots, often BIPOC-led nonprofit organizations throughout our region. Our Meet & Greet events offer us a way to engage with these organizations and as a result, we have seen an increase in first-time grant requests from these under-resourced nonprofits. Lifting them up and supporting their "boots-on-the-ground" services to those in need has been a critical part of our equity work.

The Community Foundation's Placemaking and Marketing committees also spearhead efforts to provide limited sponsorship dollars to events along the Michigan Avenue corridor, particularly those that reach culturally diverse audiences. And our most recent leadership project, Play Michigan! is the region's only inclusive playground where children of all abilities can experience the joy of play together.

We have taken great pride in our equity work over the past few years, but we know there is so much more to do. We look forward to our continued efforts.

## General Fund Types

#### Flexible Donor-Advised Fund (DAF)

Open your DAF in minutes with a new online application, lower fees, and no minimum retained balance. Take advantage of our vast expert knowledge of our community's needs and hundreds of nonprofits to fully customize your charitable giving.

#### **Designated Fund**

Support the charitable organization(s) of your choice, in perpetuity.

#### **Field of Interest Fund**

Concentrate your giving on a particular issue such as food insecurity, protecting the environment, or supporting the arts. We then direct your giving to the nonprofits currently addressing your concerns.

#### **Agency Fund**

Set up by nonprofits and individuals who support them to provide permanent sources of revenue for individual nonprofits. See page 30 for a list of our 191 agency funds.

### **Legacy Fund (Testamentary)**

Ultimately funded through your estate plan, the Fund will become active after your lifetime. The Community Foundation invests and protects your Fund, ensuring your charitable intentions are carried out for you, forever. A Legacy Fund Agreement also allows you to make changes to your plan without having to amend your will, trust, or other beneficiary designations.

# Why Our Donor-Advised Funds Are Superior

Professional advisors usually recommend the Community Foundation to their clients who want personalized service from staff who know the community's needs. But now, our donor-advised funds (DAFs) are superior to those at commercial institutions. We offer an online DAF application that is shorter and easier than the commercial apps, eliminated our minimum balance, and lowered our fees.

#### Benefits of establishing a Donor-Advised Fund with the Community Foundation include:

- Maximum charitable tax advantages bunch multiple years of contributions to exceed the tax deduction threshold and make grants over time
- → Flexibility you decide how and when to give
- Competitive fees that ultimately support your community
- → Access to resources and annual events that inform donors about community needs and impactful grantmaking opportunities
- Personalized services and local knowledge professional staff offer giving advice, fund management, and rewarding charitable connections
- → Quick and easy set-up options apply online or meet with us in person to set up your DAF
- → Opportunity to give anonymously, if desired
- No minimum retained balance

Having a donor-advised fund at the Community Foundation is like creating your own foundation – but without the administrative work and expense. Just enjoy charitable giving and leave the rest to us!

# **Agency Fund Benefits**

An Agency Fund is an endowment fund created by a nonprofit to exclusively benefit that nonprofit, forever.

- → Establishing an endowment fund creates sustainable income for your organization and can attract major planned gifts that you might not otherwise receive. Your fund is truly endowed permanent and protected forever. This is important to donors who want their investment to be their legacy.
- → Because your fund is pooled with hundreds of other funds at the foundation, your organization benefits from a diverse investment portfolio with outstanding returns that typically come only with very large funds.
- → Similar to commercial investment companies, we charge a small fee from your fund's earnings to manage your fund. But unlike for-profit institutions, the fees you pay support our mission and invest in our community.
- The Community Foundation is trusted and well-respected throughout the region, bringing credibility to your organization and your fund.
- Our professional development staff can help you grow your fund by promoting it to your donors, foundation donors and professional advisors in the community who trust us. We will also meet with your major donors and your board to answer their questions.
- → Low minimum investment of \$10,000 to open your fund. When the fund reaches \$50,000, you may choose to accept distributions or reinvest them for optimal growth of your fund. Distributions are calculated on a 12-quarter rolling average to even out market fluctuations.

The Potter Park Zoological Society has had a longstanding beneficial relationship with the Community Foundation. As we have been considering an endowment fund for many years, having them manage it was the logical choice. I highly recommend all nonprofits create an endowment fund as they make efforts to provide future sustainability for their organizations.

# Maximize Your Charitable Giving

With today's high standard tax deduction (\$14,600 for single individuals and \$29,200 for married couples), fewer people are itemizing their deductions. However, there are still things you can do to maximize the tax benefits of your charitable giving, and the Community Foundation is a great resource to help you at no cost.

Create or use your Donor-Advised Fund (DAF) at the Foundation to "bunch" multiple years of gifts into one year to take advantage of itemizing. Then, make grants from your DAF over time to provide regular support to your favorite organizations, even in years when you will not itemize.

Use your IRA to make a Qualified Charitable Distribution (QCD) gift to the Foundation. If you are age 70 1/2 or older, this may be a tax-smart way to directly transfer up to \$100,000 per year to the Foundation without having to claim the distribution as income. And you can use your QCD or Required Minimum Distribution (RMD) to create your own fund at the Foundation or contribute to an existing fund.

**Stocks, bonds, and mutual funds make great gifts.** Simply transfer appreciated securities straight to the Foundation rather than selling first, and typically, you avoid capital gains tax. Direct this gift to one of our 560+ existing funds or create a fund of your own.

# The Izzo Legacy: Leading By Example

In the heart of East Lansing, the Izzo family's commitment to service and community is woven deeply into the fabric of daily life. At the helm are Tom and Lupe Izzo, whose unwavering dedication to their hometown and its residents has left an indelible mark on the landscape of philanthropy.

In 2019, Lupe saw an opportunity to channel her generosity into positive action. Teaming up with Playmakers, she spearheaded the inaugural Izzo Legacy 5K Run/Walk/Roll event, aiming to unite the community and support local charities that have long been pillars of strength in the Lansing area. Their vision has become an annual tradition, drawing participants from all walks of life. Fast forward to 2024, the event boasts over 5,000 participants, making it the largest 5K event in mid-Michigan.

In 2019, they solidified their commitment to community welfare by establishing the Izzo Legacy Fund, a 501(c)(3) nonprofit organization. The Izzo Legacy was envisioned as a conduit to empower individuals to help organizations effect meaningful change in the community. Their dedication to the cause, coupled with outstanding support from sponsors, donors, and volunteers, has seen the initiative flourish, resulting in nearly \$700,000 raised for charity partners since its inception.

"Tom and I have always believed in the importance of giving back to the community that has given us so much," she remarked. "The Izzo Legacy provides us with an opportunity to formalize our commitment to making a difference and to inspire others to join us in this noble pursuit."

Recognizing the transient nature of individual contributions, they set their sights on creating a lasting impact through the establishment of The Izzo Legacy Endowment Fund here at the Community Foundation.

# **Local Impact Investing**

A new tool to create positive change in our region.

Since 2017, the Community Foundation's strategic direction has been to create a vibrant region that attracts and retains a talented workforce. To that end, we have led placemaking initiatives along the Michigan Avenue corridor – the backbone of our three-county region – including projects that create a vibrant downtown riverfront.

#### What's New

Our region is now facing a severe housing and childcare crisis. We need affordable, attainable workforce housing and childcare for our residents, which also attracts new businesses to our region. It will take a collective effort by government, private, and philanthropic resources to make an impact.

### **Our Responsibility**

The Foundation must do our part to address this crisis, while staying true to our current focus on the corridor. But it will require resources beyond our grantmaking funds to make a difference. **That's where Local Impact Investing comes in.** By investing a small portion of our assets here in our community, we can effectively contribute to the solution. For 50 years, foundations across the country have used Local Impact Investing to make positive change in their communities that grantmaking alone could never do.

Different than traditional investing, Impact Investing must generate both a financial return as well as a tangible social or community benefit – in this case, attainable housing and childcare. And unlike grants, investments are loans, repaid to the Foundation with a financial return, then "recycled" back into the community through additional investments.

# **Our Grantmaking**

Our annual grantmaking is one of the many ways the Community Foundation supports nonprofits in our region. Since the Foundation's first grant in 1989, we have awarded more than \$78 million to organizations in Ingham, Eaton, and Clinton counties. Last year we awarded over \$1.2 million through four grant opportunities – Impact, Capacity, Mini, and Youth.

**Impact Grants** provide funding for projects or programs that either allow an organization to create greater impact with those they currently serve, or to extend their work to under-served populations. **Capacity Building Grants** support a nonprofit's efforts to strengthen their organizational infrastructure through planning, training, coaching, or strategy development. Building an organization's internal capacity is essential for sustainability.

**Mini-Grants** support small organizations with operating budgets under \$200,000. These requests are reviewed and funded by our generous donor-advised fundholders.

**Youth Grants** are awarded by the Youth Advisory Council, a group of high school students from schools throughout the tri-county area. Grant decisions are made based on issues that are important to teens as determined by a tri-annual youth needs assessment.

But the Community Foundation offers more than grant support to nonprofits in our region. As a valued partner, we offer no-cost learning opportunities on a range of topics important to nonprofit leaders. We also host networking events to help connect smaller organizations with each other and explore opportunities for collaboration.

The Foundation's Community Investment team is committed to providing exceptional customer service to our nonprofits by helping them navigate our many offerings and sharing our collective expertise.

## **Underground of Good**

The Underground of Good is a social, member-based giving group that targets young professionals and emerging philanthropists who want to invest in the greater Lansing area. Together, members pool donations, meet socially, and award grants to causes they care about in the community. Since its inception in 2016, the Underground of Good has donated more than \$94,000 to 30 nonprofits in Mid-Michigan.

#### How it works:

You give \$500 every year: \$400 to quarterly grants the group makes to local charities (\$100/quarter) and \$100 invested in an endowment fund at the Community Foundation.

The group meets quarterly at local restaurants. Every meeting has a theme, and members suggest local charities working to address issues related to the theme. From those suggested, the group randomly selects three organizations for members to vote on the charity they want to support with that quarter's grant.

Each grant is made up of each member's \$100 quarterly contribution and any additional gifts or matching donations the group receives.

Guided by two dedicated volunteer co-chairs, and with the support of the Community Foundation, the Underground of Good stands as a beacon of philanthropy in action. As members come together, forge connections, and invest in long-term impact, they not only redefine the landscape of giving but also lay the foundation for a more resilient and compassionate community, poised to thrive for generations to come.

# Fish Ladder Music Park Jumpstarted

Located on the bank of the Grand River adjacent to Old Town, Burchard Park and the Brenke Fish Ladder are underdeveloped public spaces with tremendous untapped potential. Past events like Dam Jam in 2019, 2021, and 2023 have demonstrated the potential to transform the old historical site. The Fish Ladder Music Park will use an historic architectural wonder with a water feature to create a unique musical performance venue on the riverfront that is accessible to people of all abilities.

Jumpstarting the project in 2023, the Foundation received a state appropriation of \$1.7 million, thanks to Senator Sarah Anthony, Representative Angela Witwer, and the State appropriations committee. Total costs are currently estimated at \$2.3 million, so the Foundation has started fundraising, and all improvements to the park will create a unique destination venue for both residents and visitors. A stage, theatre-style seating, a plug-and-play sound system, and creative lighting will transform the fish ladder. In addition, amenities will be added to the park, including an "electric forest," outdoor fireplace and seating, and improved accessibility for all people regardless of ability. Permanent naming opportunities will be available for the stage, fireplace, and other amenities. All donations from individuals and businesses will be matched by the Foundation, dollar-for-dollar.





# \$8,291,126 of Impact


### **GRANTS & AGENCY DISTRIBUTIONS**


